## Introduction

As a Canadian Crown corporation, Windsor-Detroit Bridge Authority (WDBA) is responsible to the public. The organization’s Annual Public Meeting (APM) is an opportunity for WDBA to share information on its operations and activities and to solicit feedback from the public. The 2024-2025 APM was held by means of an audio-visual presentation posted to the Gordie Howe International Bridge project website ([gordiehoweinternationalbridge.com](http://gordiehoweinternationalbridge.com)) which also serves as WDBA’s corporate site on January 6, 2026.

## Public Notification

Notice of the APM was made widely available using several communications channels:

- Bilingual notification was posted on WDBA’s Annual Public Meetings website page and on the Meetings and Events website page on December 5, 2025, in advance of the meeting on January 6, 2026.
